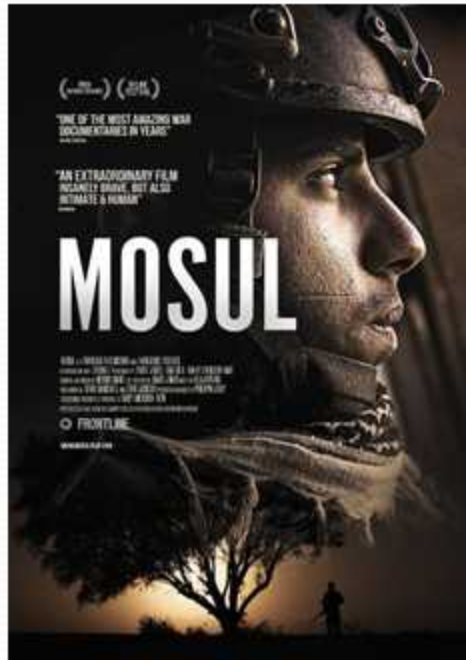

TAX CREDIT BENEFITS

- **Morocco:** The Kingdom offers a 30% Tax credit on approved local spent. To qualify for the rebate the Film Producer must escrow 5% of the projected tax rebate in a separate account, to be released upon conclusion of the audit. The Tax credit is then paid to the Production Service Company, which in turns pays the balance to the Producer. It takes about 4 months starting from completion of the audit. Projected tax credit: \$ 1,500,000
- **Belgium:** The Belgian Tax credit/shelter offers a 40% Tax credit. To qualify for the rebate the Film Producer must co-produce with a Belgian Company. The Tax credit is paid to the Producer upon issuance of a completion bond. To qualify for a full 40%, 70% of that projected amount has to be paid to EEU nationals. Projected tax credit: \$ 1,000,000
